




History of Trade since 1600

Biomass Market anno 2010

- Sustainable biomass resources and supplies the foundation for the biobased economy.
- Biomass & Biofuel Markets HAVE globalized
- Strong policy efforts: strategies, certification.
- Major market activity: supplies from DC's, new generation fuels, power generation activity and biomaterials.
- Many impacts (food supplies, land use, social) and interactions (development, markets) poorly understood.



Key trends bio-ethanol (status 2008)

- two leading *ethanol* producers: United States (26.8 million tonnes) and Brazil (21.3 million tonnes): 91% of the world production.
- US largest consumer: 28.4 million tonnes; 4.6% imported.
- Brazilian consumption amounted to approximately 16.5 million tonnes.
- EU consumption 2.6 million tonnes, the largest users being France, Germany, Sweden and The Netherlands.

 Data related to fuel bioethanol trade imprecise due to various potential enduses of ethanol (i.e. fuel, industrial use, and beverage use) and also because of the lack of proper codes for biofuels.

Key trends biodiesel (2008)

- World *biodiesel* production increased six-fold from 1.8 million tonnes in 2004 to 10.6 million tonnes in 2008.
- EU produces about two-thirds of this (7.8 Mton); Germany, France, Italy and Spain top producers.
- However, EU production declined 7% in 2009 because of strong competition from abroad.
- EU Biodiesel consumption 9.2 Mton (Germany 2.9 Mton)
- Other main biodiesel producers include the United States, Argentina and Brazil.
- International biodiesel trade has been increasing strongly since 2005.
 - US gross exports increased from negligible levels in 2005 to about 1.4 million tonnes in 2008
 - Argentine exports to EU increased from 70 000 tonnes in 2008 to ~ 1 million metric tonnes in 2009

Key trends wood pellets

- Strong growth production, consumption and trade of wood pellets since late 90-ies.
- In 2008 ~ 8 million tonnes pellets produced in 30 European countries, 1.8 million tonnes in the US and 1.4 million tonnes in Canada.
- Consumption is high in many EU countries and the US.
- European consumption for 2009 ~ 8.5 million tonnes.
- The largest EU consumers are Sweden (1.8 million tonnes), Denmark, the Netherlands, Belgium, Germany and Italy (all roughly one million tonnes).

Wood pellet trade

- First wood pellet *trade* in 1998: British Columbia (Canada) to Sweden.
- Canada major exporter to Europe (especially Sweden, the Netherlands and Belgium) and to the US.
- 2008: US starts export wood to Europe, Canadian to Japan.
- Total imports EU 2009 ~ 3.4 million tonnes; about half intra-EU trade.
- Total export ~ 2.7 million tonnes, predominantly intra –EU trade.




Barriers and opportunities for bioenergy trade (to be published)



Discusses implications of large scale bioenergytrade on global fleet Key Production Areas and Shipping Routes




What?: 2nd Generation Biofuels and Trade -an exploratory study

- new conversion technologies
- development of production costs
- Analyses potential competition with other cellulose consuming industries



sustainability certification schemes

Overview study: 59 initiatives (regulation + systems) included

- All relevant for (some) sustainability issues and/or
- Various parts of the bioenergy value chain



* Substantially more forestry certification systems exist

Task 40: Sustainable International Bioenergy trade

EU-Sustainability requirements

- For biofuels and other bio liquids for energy purposes:
- CO2: > 35% better then fossil equivalent
- Biodiversity: no go areas
- Carbon sinks: preservation of status of areas
- EU: Cross compliance requirements (not for companies?)

NB: For waste and residues (not from agriculture, aquaculture, fishery, forest): only CO2-requirement

Task 40: Sustainable International Bioenergy trade

Ethanol

1. CO2-requirement

- > 35% better then fossil equivalent
- Temporary exception existing installations
- In 2017 second step: 50% (depending on review)
- From 2017 60% for new installations

-Outside EU: CO2-calculation with Annex V

• Defaults for biofuels

-Within EU: cultivation defaults required

2. Biodiversity: no go areas

- Forest
- Primary forest and other wooded land
- Areas designated for nature protection purposes /
- for protection of rare, threatened, endangered species
- Unless evidence for no interference with these purposes
- -Highly bio diverse grassland
 - Commission shall establish criteria and geographic ranges

Task 40: Sustainable International Bioenergy trade

High carbon stock (preservation of status)

- Wetlands
- Continuously forested areas
- Canopy cover between 10 and 30%

4. Peatland (preservation of status)

Unless evidence for no drainage of previously undrained


