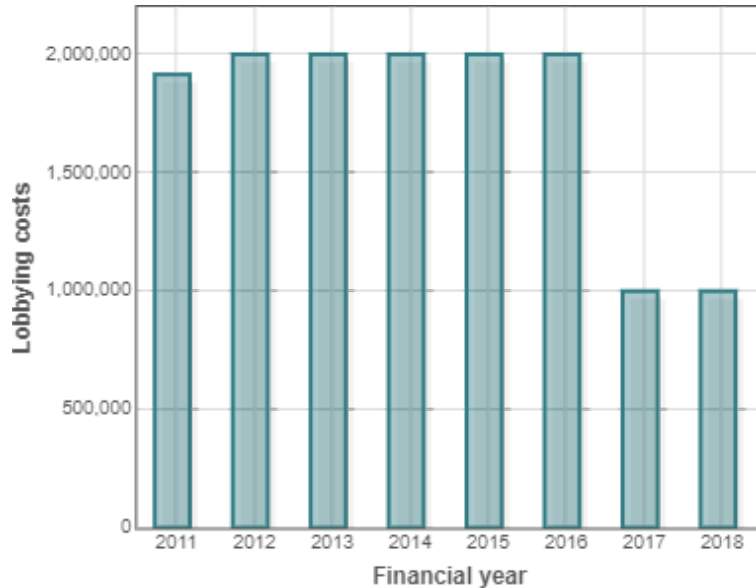

RWE is one of the largest energy providers in Europe. Our motto: Zukunft.Sicher.Machen. We stand for safety and reliability in energy supply - that's RWE. With its three operating segments - Lignite & Nuclear Energy (RWE Power), European Electricity Generation with Gas, Hard Coal, Hydropower and Biomass (RWE Generation) and Energy Trading (RWE Supply & Trading), RWE AG is indispensable for the functioning of the energy system and for security of supply in Europe. The fourth pillar is the majority stake in innogy SE with its three business segments Renewable Energies, Network & Infrastructure as well as Sales. In the 2018 financial year, RWE posted "stand-alone" (ie excluding the net and distribution activities of innogy) with earnings of € 1.5 billion (adjusted EBITDA) and just under 18.
